<b>4506-C / Tax Transcripts</b>	<p><b>4506-C/Tax Transcripts:</b> A signed 4506-C will be processed and tax transcripts obtained for all borrowers and all years in which income or loss was used in the underwriting decision.</p> <ul style="list-style-type: none"> <li>• Tax transcripts for personal tax returns are required when tax returns are used to document borrower's income or any loss and must match the documentation in the loan file.</li> <li>• W-2 transcripts are required to validate W-2 wages.</li> <li>• Transcripts must be obtained directly from the IRS via a third party.</li> <li>• Transcripts are not required for business tax returns.</li> </ul>																			
<b>Appraisal</b>	<p>All appraisals must be ordered and processed in compliance with Appraiser Independence Requirements (AIR). Appraisals on wholesale transactions must be ordered through a Plaza approved Appraisal Management Company (AMC). 	<ul style="list-style-type: none"> <li>The CDA is required to support the value of the appraisal. If the CDA returns a value that is “Indeterminate” or if the CDA indicates a lower value than the appraised value by more than 10%, then one (1) of the following requirements must be met: <ul style="list-style-type: none"> <li>A Clear Capital BPO and a Clear Capital Value Reconciliation of Three Reports is required. The Value Reconciliation will be used for the appraised value of the property. OR,</li> <li>A field review or 2nd full appraisal may be provided. The lower of the two values will be used as the appraised value of the property.</li> </ul> </li> <li>If two (2) full appraisals are provided, a CDA is not required.</li> </ul> <p><b>Transferred Appraisals:</b> Transferred appraisals are not allowed.</p>
<b>ARM Adjustments</b>	Reserved for future use.
<b>Assets/Down Payment/Gifts</b>	<p>Follow the DU findings and <b>Fannie Mae Guidelines</b> except as detailed below:</p> <ul style="list-style-type: none"> <li>Eligible assets must be held in a US account.</li> <li>Large deposits inconsistent with monthly income or deposits must be verified if using for down payment, reserves or closing costs.</li> <li>Fannie Mae approved third party suppliers and distributors that generate asset verification reports are permitted for the purpose of verifying assets.</li> <li>A written VOD as a stand-alone document is not acceptable. <ul style="list-style-type: none"> <li>A system generated automated VOD may be used as a stand-alone documentation if provided by a verifiable institutional bank.</li> </ul> </li> </ul> <p><b>Gift Funds:</b> Gift funds may be used once borrower has contributed 5% of their own funds.</p> <p><b>Business Funds:</b></p> <ul style="list-style-type: none"> <li>Cash flow analysis required using most recent three (3) months business bank statements to determine no negative impact to business. Business bank statements must be no older than the latest three months represented on the year-to-date profit and loss statement</li> <li>Business bank statements must not reflect any NSF’s (non- sufficient funds) or overdrafts</li> <li>If borrower(s) ownership in the business is less than 100%, the following requirements must be met: <ul style="list-style-type: none"> <li>Borrower(s) must have majority ownership of 51% or greater</li> <li>The other owners of the business must provide an access letter to the business funds</li> <li>Borrower(s) % of ownership must be applied to the balance of business funds for use by borrower(s)</li> </ul> </li> </ul> <p><b>Retirement Accounts:</b> If funds are being used for down payment or closing costs, evidence of liquidation of retirement funds is required.</p> <p><b>Virtual Currency:</b> Virtual currency that has been exchanged into U.S. dollars is acceptable for down payment, closing costs, and reserves provided the following requirements are met:</p> <ul style="list-style-type: none"> <li>There is documented evidence that the virtual currency has been exchanged into U.S. dollars and is held in a U.S. or state regulated financial institution, and</li> <li>The funds are verified in U.S. dollars prior to the loan closing.</li> <li>A large deposit may be from virtual currency that was exchanged into U.S. dollars. The lender must obtain sufficient documentation to verify the funds originated from the borrower’s virtual currency account.</li> <li>Virtual currency may not be used for the deposit on the sales contract (earnest money) for the purchase of the subject property.</li> </ul>
<b>Borrower Eligibility</b>	<p><b>Eligible Borrowers:</b></p> <ul style="list-style-type: none"> <li>All borrowers must have a valid Social Security Number</li> <li>U.S. citizens</li> <li>Permanent resident aliens with evidence of lawful residency <ul style="list-style-type: none"> <li>Must be employed in the United States for the past 24 months.</li> </ul> </li> <li>Inter Vivos Revocable Trusts – Refer to <b>Plaza’s Living Trust Policy</b> requirements.</li> <li>Non-occupant borrowers must be a related family member of the borrower(s).</li> <li>First time homebuyer: A first time homebuyer is defined as anyone who has not owned a home in the past three (3) years. For loans with more than one (1) borrower where at least one borrower has owned a home in the past three (3) years, first-time homebuyer requirements do not apply. All First-Time Homebuyers must meet the following requirements: <ul style="list-style-type: none"> <li>Maximum loan amount of \$1,500,000.</li> <li>FTHB reserve requirements per the <b>Reserves</b> section in these guides.</li> <li>Investment property transactions not allowed</li> </ul> </li> </ul>

	<p><b>Ineligible Borrowers:</b></p> <ul style="list-style-type: none"> <li>• LLCs, Corporations or Partnerships</li> <li>• Non-Revocable Trusts</li> <li>• Non-Permanent Resident Aliens</li> <li>• Borrowers with Diplomatic Immunity</li> <li>• Land Trusts</li> <li>• Foreign Nationals</li> <li>• Life Estates</li> <li>• Guardianships</li> <li>• Borrowers with any ownership in a business that is Federally illegal, regardless if the income is not being considered for qualifying</li> </ul>
<b>Co-Ops</b>	<ul style="list-style-type: none"> <li>• The co-op project must be reviewed and approved by Plaza prior to closing</li> <li>• Must meet Fannie Mae cooperative project standards</li> <li>• Must be located in the states of California, Connecticut, Florida, Illinois, Maryland, New Jersey, New York or Washington D.C.</li> <li>• Refer to Plaza's <b>Project Standards</b> for Plaza's complete co-op requirements</li> </ul>
<b>Credit</b>	<p><b>Credit Standards:</b> A tri-merged credit report is required. Unless otherwise addressed below, Fannie Mae underwriting guidelines must be followed for evaluating a borrower's credit history.</p> <p><b>Credit Scores:</b></p> <ul style="list-style-type: none"> <li>• All borrowers must have a minimum of two (2) credit scores. If one credit repository is frozen, the credit scores from the unfrozen bureaus are utilized.</li> <li>• The lowest qualifying score of all applicants is used to qualify. The qualifying score is the lower of 2 or middle of 3 scores and must be reviewed for each borrower.</li> </ul> <p><b>Trade Lines:</b> Per DU findings</p> <p><b>Disputed Trade Lines:</b></p> <ul style="list-style-type: none"> <li>• All disputed trade lines must be included in the DTI if the account belongs to the borrower unless documentation can be provided that authenticates the dispute.</li> <li>• Derogatory accounts must be considered in analyzing the borrower's willingness to repay. However, if a disputed account has a zero balance and no late payments, it can be disregarded.</li> </ul> <p><b>Mortgage History:</b></p> <ul style="list-style-type: none"> <li>• If the borrower(s) has a Mortgage in the most recent twenty-four (24) months, a mortgage rating must be obtained, reflecting 0x30 in the last twenty-four (24) months.</li> <li>• The mortgage rating may be on the credit report or a VOM.</li> <li>• If the mortgage holder is a party to the transaction or relative of the borrower, cancelled checks or bank statements to verify satisfactory mortgage history is required.</li> <li>• The mortgage history requirements are applicable to all mortgages and all borrowers on the loan.</li> <li>• The borrower(s) credit report must be reviewed to determine the status of all mortgage loans. For any mortgage on the credit report it must be verified that none of the mortgages are subject to a loss mitigation program, repayment plan, loan modification or payment deferral plan.</li> </ul> <p><b>Rental History:</b> Per DU findings</p> <ul style="list-style-type: none"> <li>• If DU does not ask for rental verification, none is required</li> <li>• Any rental verification provided by the borrower must reflect 0x30 in the last 12 months</li> <li>• Borrowers living rent free are eligible</li> </ul> <p><b>Bankruptcy - Chapter 7, 11, 13:</b> Seven (7) years since discharge / dismissal date</p> <p><b>Foreclosure:</b> Seven (7) years since completion date</p> <p><b>Notice of Default:</b> Seven (7) years since filing date</p> <p><b>Short Sale / Deed-in-Lieu:</b> Seven (7) years since completion/sale date</p>

	<p><b>Forbearance:</b></p> <ul style="list-style-type: none"> <li>Any forbearance resulting in a subsequent loan modification/repayment plan is considered a significant derogatory credit event and subject to a 7 year waiting period.</li> <li>Any loan(s) shown to be in active forbearance is considered a significant derogatory credit event and is ineligible.</li> <li>If any loan was subject to a prior forbearance granted between 4/1/20 and 4/1/21, if such forbearance has been exited and all subsequent payments must have been made on time since the exit then such event will not be considered a significant derogatory credit event.</li> <li>Loan file must contain a letter of explanation from the borrower/guarantor detailing the reason for forbearance and that the hardship no longer exists.</li> </ul> <p><b>Mortgages Settled for Less, Renegotiated or Short Payoffs:</b> Seven (7) years since settlement date</p> <p><b>Loan Modifications:</b></p> <ul style="list-style-type: none"> <li>If the modification was due to hardship or included debt forgiveness, seven (7) years seasoning since modification is required.</li> <li>Lender initiated modification will not be considered a derogatory credit event if the modification did not include debt forgiveness and was not due to hardship as evidenced by supporting documentation. No seasoning requirement would apply.</li> </ul> <p><b>Multiple Derogatory Credit Events:</b> Multiple derogatory credit events are not allowed, regardless if seasoned over seven (7) years. A mortgage with a Notice of Default filed that is subsequently modified is not considered a multiple event and a mortgage with a Notice of Default filed that is subsequently foreclosed upon or sold as a short sale is not considered a multiple event.</p> <p><b>Tax Liens, Judgments, Charge-Offs, &amp; Past-Due Accounts:</b></p> <ul style="list-style-type: none"> <li>Must be satisfied or brought current prior to or at closing.</li> <li>Cash-Out proceeds from the subject transaction may not be used to satisfy judgments, tax liens, charge-offs or past-due accounts.</li> <li>Payment plans on prior year tax liens/liabilities are not allowed and must be paid in full.</li> <li>If the most recent tax return or tax extension indicate a borrower owes money to the IRS or State Tax Authority, evidence of sufficient liquid assets to pay the debt must be documented if the amount due is within ninety (90) days of loan application date or if the tax transcripts show an outstanding balance due. A payment plan for the most recent tax year is allowed if the following requirements are met: <ul style="list-style-type: none"> <li>Payment plan was setup at the time the taxes were due. Copy of the payment plan must be included in the loan file</li> <li>Payment is included in the DTI</li> <li>Satisfactory pay history based on terms of payment plan is provided</li> <li>Payment plan is only allowed for taxes due for the most recent tax year, prior years not allowed. For example, borrower files their 2019 return or extension in April 2020 A payment plan would be allowed for taxes due for 2019 tax year. Payment plans for 2018 or prior years would not be allowed</li> <li>Borrower does not have a prior history of tax liens</li> </ul> </li> </ul> <p><b>Medical Collections:</b> Per DU findings</p> <p><b>Credit Inquiries:</b></p> <ul style="list-style-type: none"> <li>All inquiries that have taken place within 120 days of the credit report date should be explained by the borrower and documented accordingly.</li> <li>Borrower must be qualified with any new debt.</li> </ul>
<b>Flood Insurance</b>	Adequate insurance is required for HOI and flood as applicable. For Insurance requirements refer to Plaza's <a href="#">Hazard and Flood Insurance Policy</a> .
<b>Geographic Restrictions</b>	<p><b>Hawaii:</b> Properties in Lava Flow Zones 1 or 2 are not allowed.</p> <p><b>New York:</b> New York city short-term rental qualifying income is not allowed.</p> <p><b>West Virginia:</b> Delegated deliveries only.</p>

<b>Identity of Interest / Non-Arm's Length</b>	<p>A non-arm's length transaction exists whenever there is a personal or business relationship with any parties to the transaction which may include the seller, builder, real estate agent, appraiser, lender, title company or other interested party. The following non-arm's length transactions are eligible:</p> <ul style="list-style-type: none"> <li>• Family sales or transfers</li> <li>• Property seller acting as their own real estate agent</li> <li>• Relative of the property seller acting as the seller's real estate agent</li> <li>• Borrower acting as their own real estate agent</li> <li>• Relative of the borrower acting as the borrower's real estate agent</li> <li>• Borrower is the employee of the originating lender and the lender has an established employee loan program. Evidence of employee program to be included in loan file. If the borrower has an ownership interest an exception is required.</li> <li>• Originator is related to the borrower. If the borrower has an ownership interest an exception is required.</li> <li>• Borrower purchasing from their landlord (cancelled checks or bank statements required to verify satisfactory pay history between borrower and landlord)</li> </ul> <p>Gifts from relatives that are interested parties to the transaction are not allowed, unless it is a gift of equity.</p> <p>Real estate agents may apply their commission towards closing costs and/or prepaids if the amounts are within the interested party contribution limitations.</p> <p>Investment property transactions must be arm's length.</p> <p>Other non-arm's length transactions may be acceptable on an exception basis.</p>
<b>Income &amp; Employment</b>	<p><b>Stability of Employment &amp; Income:</b> Income must be stable and meet the following requirements to be considered for qualifying:</p> <ul style="list-style-type: none"> <li>• A two-year employment history is generally required.</li> <li>• If the borrower(s) have less than a two year employment and income history, a written analysis must be provided to justify the determination that the income used to qualify the borrower is stable.</li> <li>• Borrower(s) must execute an attestation at closing confirming no changes to employment and income listed on the final loan application as a result of COVID-19 impacts.
